SENIOR SEASONAL/SECONDARY PROGRAM	This program offers Open Peril coverage, subject to exclusions, for manufactured homes that are used as a seasonal/secondary residence by the titled owner, who is 45 years old or older.
STANDARD SEASONAL/SECONDARY PROGRAM	This program offers Open Peril coverage, subject to exclusions, for manufactured homes that are used as a seasonal/secondary residence by the titled owner, who is under 45 years old.
RENTAL PROGRAM	This program offers Open Peril coverage, subject to exclusions, for manufactured homes the titled owner rents to others.
TENANT PROGRAM	This program offers Named Peril coverage on personal property for the insured who pays rent to a manufactured home owner.
